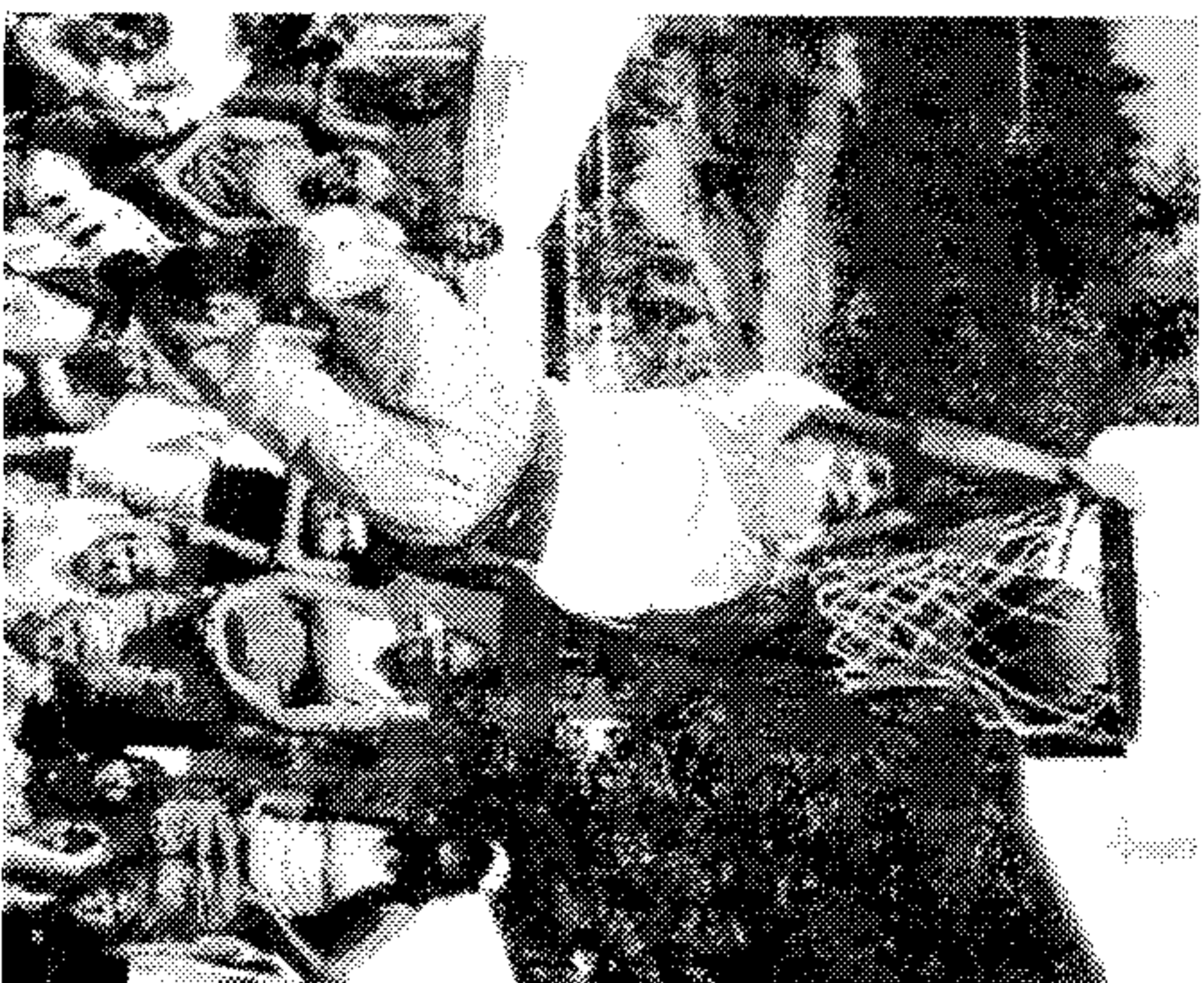


## RELEASE WAIVER AND sportsmanship pledge
